Remember that ALL placements are made on a month’s trial basis which gives more of a chance to realistically assess risk in relation to all concerned.

Please ensure that ALL risks are disclosed. Good quality and open communication is crucial for safe matching of placements. NEWFOCAS expects open and honest written disclosure of previously know about risky or dangerous behaviours. Failure to disclose such, with subsequent unacceptable risk to carers or others in placement may result in the immediate withdrawal of a placement. Note that totalling scores of Frequency/Severity on all identified Risks may be useful tool for future Risk Reviews.
